The Top 10 Actions To Building A Stronger Sales Team

1) **Clear communication.** Use the KISS (*Keep It Short and Simple*) method – it does not have to be complicated to out line exactly what is expected

of them daily, weekly, monthly and quarterly.

2) Motivate your current sales team with incentives, rewards and, most importantly,



acknowledgements of a job well done. In many of my interviews with dissatisfied sales professionals they lament the fact that their achievements are not noticed nor seem to matter.

- 3) **Praise in public**, criticize in private.
- 4) **Promote from within.** Nothing motivates current sales team members more than knowing they, too, can be promoted when they prove themselves worthy.
- 5) **Be accessible.** Having a manager actually listen and be available may make the difference to that sales rep as to whether they close or lose the sale.

Alert Supervisors To Little Known 'Association-Bias' Law

By now, your supervisors know it's illegal to discriminate against someone because of his or

her disability. But do they also know about a lessobvious part of the ADA that makes it illegal to discriminate against people because they have an association with a person who has a disability.

For example, you can't refuse to hire someone because of an unfounded fear that the person will be excessively absent or unproductive because they need to care for a disabled child. The ADA's association provision covers hiring, firing and other terms and

conditions of employment. *Other examples of discriminatory actions:*

Firing or refusing to hire someone based on concerns that the person will acquire a condition from a family member or friend



- Refusing to provide health insurance for an employee's family member with a disability when you generally provide health insurance for employee dependents
- Harassing someone based on the individual's association with a person with a disability
- ♦ Firing, refusing to hire or denying benefits to someone because of concern that the organization's image will be hurt by an employee's association with individuals with disabilities (*Example:* Discriminating against an employee who provides volunteer services for AIDS patients.)

Spot That E-Mail Virus

In case your anti-virus program doesn't catch every E-Mail based Internet worm, try the following tip to be warned if you are infected: Add a fake E-Mail address in your address book and name it with an obvious name (like "virus alert") If you get infected, the message sent by the worm to that invalid E-Mail account will bounce back to you and you'll see the bounced message warning.

Meeting Communications

When answering a question at a meeting, it is important to be specific. Be direct, short, and leave no room for interpretation.

Most of us tend to give a long explanation to set up the actual answer. By then most people have either forgotten the question or you have lost their interest.

If you are specific when answering you can add additional details if needed.

- 6) Assign mentors to new hires. A seasoned sales rep can help the new hire avoid the rookie mistakes and accelerate his/her ramp-up time.
- 7) **Offer training consistently throughout the year** to your sales team. Always keep sharpening the saw.
- 8) **Have a book of the month** that all read and discuss. Hundreds of excellent books exist that relate to selling and business success.
- 9) **Build your bench.** If you see top talent from your competitors in the field, begin a relationship with them

so you can contact them when you have an opening. It's not IF you will have an opening – it's when. People get promoted, move, quit or are fired.

Guidelines For Roth IRA Contributions

Taxpayers confused about whether they can contribute to a Roth IRA should consider guidelines based on the following categories:

✓ Income Limits – To contribute to a Roth IRA, you must have

- compensation (e.g., wages, salary, tips, professional fees, bonuses). These limits vary depending on your filing and marital statuses.
- ✓ Age There is no age limitation for Roth IRA contributions.
- ✓ Contribution Limits In general, if your only IRA is a Roth IRA, there is a maximum. The maximum contribution limit phases out depending on your modified adjusted gross income.
- Spousal Roth IRA You can make contributions to a Roth IRA for your spouse provided you meet the income requirements.
- ✓ Time Contributions to a Roth IRA can be made at any time during the year or by the due date of your return for that year (not including extensions).

Roth IRA contributions are not tax deductible and are not reported on your tax return. You do not include in your gross income, and therefore are not taxed on, any qualified distributions. Visit the IRS Web site at www.IRS.gov for more information.

We are deeply thankful and grateful for the gift of their words.



"Emily was one of the strongest women I have ever known. Small but full of fire and passion for truth! She will always be a part of my heart. It is hard to keep my composure anywhere. Some days I succeed, some days I fail miserably. I cannot imagine if it is this hard for me, what it must be like for you. Your words were beautiful and I am so thankful that even in death, Emily's spirit and strength lives on to help others grow and develop. I miss her." Beth Burge, Mobile, AL

"Emily was amazing and I am so grateful for the years I got to spend with her in college. I admired her discipline, compassion and selflessness. She was a good friend to me and I will miss her until I see her again. . . I don't know if there's a day that passes by that I haven't thought about her, but I want you to know that I loved her and truly appreciated her friendship. I terribly miss you Ms. Emily. You were in my life for just a short time, but you made an impact on me beyond words. You were a friend, confidant, and a mother at times. I was blessed to have you. I will sincerely miss your radiance. You were truly a beautiful soul! I love you girl!"

"I remember speaking to Emily after she attended the Amos Lee concert, and she told me how his music re-inspired her to dance. It seems it just brought something out of her that was very encouraging. dance department talked about our "muse" in dance, who it was, that inspired us to create dance; those whose dancing inspired us to create more dance. Emily was that person for me. Maybe that was what fused us to be so close in addition to our friendship.

"It's amazing how I run across pictures of Emily, or us together, when I least expect it. She has immensely touched and enriched my life. Even though I have stepped back from the dancing world, I was so proud that she had continued on in her pathways of dance. We had both ran into obstacles through the dance program that made us second guess our abilities. And I was extremely happy to know she had carried on and found a niche in North Carolina. Emily talked about Steve, Diane and Laurie often at college. As much as she was fiercely independent, she loved her family just as fiercely.

03/23/2008 "I do think about Emily all the time. At the coffee shop where I work, there is with me every day from the beginning of December a tiny red hair girl by the name of Holly, who I called from the beginning, Emily. I would always say, 'hey Em, can you. . . . (and then), sorry I know you are Holly.'. . I would always say, 'you have to be into dancing, right?' and Holly would say no.' And I say, 'that is weird, cause Emily loves dancing and you are just like her. . .'

"I told Emily about Holly! I told her how I keep calling her Emily instead of Holly. . . She loved it. Emily would say she wanted to meet Holly.

"I don't know if my friend Devon wrote you already, but she was driving on 15-501 in Durham, stopped on a red light and a homeless person came to her car. . . she pulled the window down and gave the guy a granola bar. She keeps granola bars in her car since the memorial service. . . . The homeless guy thanked her and said that he has a great friend Emily who always gives him one too. . . This shows you what a nice person she was. . . not only giving him something, she also talked to him, she introduced herself!!!!!!!!

"I have given maybe 2 boxes of granola bars. . . still waiting to meet the homeless guy who knew Emily. . . It will take time, but one day I am sure I will get to introduce myself to him and tell him about Emily. . .

"When me and Emily lived together she had a long list of Czech words, like 'hi, how are you, thank you, your welcome. . . also she had a sentence 'turn the music up.' She only remembered turn the music up. So I would come home from work, she would say hi in English and out of the blue she would say in Czech 'turn the music up.' Even though no music was playing, that was so funny.' Jana Delezelova, Chapel Hill, NC

03/24/08 "We really appreciate staying connected with you. It helps us to feel connected to Emily. . . which is not hard. We feel Emily imbued our home with her spirit and we are grateful.

"We realized recently that our cat, Sydney, whom Emily was taking care of, and whom Emily was so good to, starting crying incessantly in early January. I took her to the vet in February and they could find nothing wrong, she was in great health. Then somehow it came to me that Sydney started crying soon after Emily's death and I may be projecting onto our cat, but we believe that she has been missing Emily terribly. So, we've given her extra attention in the spirit of Emily's loving ways with her (despite being allergic to cats!! which she never told us)." Merideth and Mark, Hillsborough, NC

03/28/08 Some one that did not know Emily but met her and attended to her in the car at the scene of the accident were Edward and Cindy Geiger. We feel they have become a part of us on the journey of grieving and healing. They put flowers out for us. We received an email this morning from Cindy, "I wanted to tell you that I turned around in the drive near the flowers yesterday and saw that someone had placed a smallish white painted cross with a rose and one daisy right beside Emily's Easter Lily arrangement. I had not been that way since Sunday, so I hadn't seen it before. I got out and looked carefully to see if there was a card or something on the cross to identify it, but there wasn't. It was not new, and made me think of the song "The Old Rugged Cross", so it seems someone had purposefully put this item there that was special and meaningful to them with a history to it. . . So you have a little Easter

mystery, or even a small Easter miracle. I thought you would like to know, and if someone comes forward saying they put it there. I'll pass their name on to you. . . That shows that people other than us remembered Emily on this special day of resurrection."

03/29/08 "There hasn't been a day that's passed by that I haven't thought of Emily. There are just certain things that remind me of her. When I see a young lady with red hair I think about her. When I listen to certain genres of music that I think she would have liked I think about her. When I see anyone dancing to ballroom I immediately think about her.

"Emily was bedrock to my completing law school. The last time we spoke, I remember her saying, 'One more semester, you are almost there!' Yesterday, while I was sitting in Circuit Court (in Kentucky) those words dawned on me, and again I thought about Emily.

"I miss her dearly. I think to myself often I wish I could have told her how much I loved her and how much she meant to me as a friend. My pain runs deep but I know it does not compare to that of the emotions of a Father, Mother, or Sister." Faudlin Pierre

Not a day goes by that we don't think of Emily. Not a day goes by that a tear is not shed. Whether a word from a friend, a song on the radio or CD, the phone ringing, riding down the road, in the silence of the night or the early morning. . . we are reminded of Emily. The best description of our current experience and grieving process is in the words of C. S. Lewis as he wrote in *A Grief Observed*, "The act of living is different all through. Her absence is like the sky, spread all over everything."

Steve, Diane and Laurie
